Plaintiff, for herself and in the first person henceforth, pursuant to Fla.R. App. P. 9.310(a), moves for issuance of a forthwith stay of execution on the judgment awarding attorney fees, pending her appeal of this matter.

I further ask that the stay be drafted so as to countermand or release whatever Defendant's attorney has filed with my bank. My debit card was declined tonight, and the bank's online statement says that there is a "garnishment order." All my funds, in the amount of \$9,189.30, are inaccessible and I have access to no money, at all. I have seen no garnishment order, and the amount of the judgment is much less than that: \$5,475. I cannot obtain the automatic stay provided for by the rule without access to my funds.

WHEREFORE, a stay should forthwith enter pending appeal, and a hearing held forthwith on Thursday, Oct. 18, at 11:00 or later, in the interest of justice. I will call the court prior to 9:00 a.m. to obtain a setting.
